- 1. Georgian law "On Consumer Rights Protection" Presentation on main principles and enforcement issues of the law;
- 2. National Quality Infrastructure: Reforms and Perspectives;
- 3. Discussion on issues raised by the private sector.

#### 4. Conclusions

- 1. Pursuant to the needs identified during the discussion at the PSDAC's meeting and in accordance with the expressed interest from private sector representatives, discussion of the draft by-law "On the rules and procedures of case investigation" provided by the Law of Georgia "On Protection of Consumer Rights" shall be defined as an agenda issue of the next PSDAC meeting. By-law is planned to be elaborated by the October 1, while according to the law, it comes into force on November 1.
- 2. Considering the proposal of the deputy General Director of the LEPL "The Unified National Body of Accreditation Georgian Accreditation Centre" the issue of defining the NNLE "Georgian Association of Testing Laboratories" and the Georgian Association of Laboratory Medicine within the PSDAC shall be discussed.
